You may select one "exclusive" item for each full 5' width of booth space rented. No more than two food vendors will be allowed to sell the same or similar main items at Anchorage Market & Festival. We will attempt to give exclusives for one or two main items to each Food Vendor. You must notify us in writing in advance to add or delete a menu item. There is no limitation on the number of food vendors who sell French fries, potato chips, onion rings, cookies, pies, cakes, coffee (not espresso), slushies, smoothies, hot or cold brewed tea and chili used as a topping.

**2017 Food Vendors have until Friday, October 20, 2017 to claim grandfather rights on exclusive foods that they sold during the 2017 Anchorage Market & Festival season and wish to sell as an exclusive in 2018. After that date, exclusives will be granted on a first come first served basis.**

A normal booth space is 10' wide x 20' deep except those located in E. Bear Boulevard are 15' wide x 20' deep. Extra booth space is available in 1' increments. Extra space must be available in your assigned row should you wish to purchase additional footage. Extra foot of food booth width is \$255 for the season. Food fee is included in rate.

# Electric

**Electrical** plugs are available to Food Vendors on a priority basis. Each food booth has available at least one 20amp duplex box that rents for \$20 per market day. Most food booths will have an additional 20amp duplex box within a reasonable distance that will sell for \$10 per market day, if needed. We also have 6 only 50amp plugs for trailers. Some or all are likely committed for the 2018 season by grandfather rights. It is each Food Vendor's responsibility to ensure that an adequate amount of electrical service is purchased for your needs.

Should you need electrical service, **it is required that vendor find the tag on each of their electrical appliances and determine their electrical needs in volts (120 usually); watts and/or amps.** Be aware of the appliance's electrical needs when you purchase them. List all needed electrical appliances below:
